The Company may and is hereby authorized to use the Dancer’s name in connection with promotion of its business, products and services and to allow others to do so, and is hereby authorized to (and to allow others to) use, reproduce, disseminate, alter and otherwise exploit any pictures, images or videos of the Dancer in any manner Company sees fit.

Nothing contained in this Release is intended for the benefit of third persons or entities except, however, that this Release shall be for the benefit of, and every mention of the Company herein shall be deemed to include equally, the officers, agents, employees, successors and assigns of the Company.
